Darwen Healthlink is a General Practice Partnership, with 4 GP Partners, 2 salaried GPs, 1 Business Manager, 1 Advanced Nurse Practitioner, 2 Clinical Pharmacists, 1 Pharmacy Technician, 5 Practice Nurses, 1 HCA, 1 Mental Health Practitioner, 1 Operations Administrator, 1 Office Supervisor, 3 Secretaries, 2 Senior Receptionist's and 6 Receptionists, 5 Administrators, 1 Senior Prescription Clerk and 3 Prescription administrators.

Darwen Healthlink is a designated training practice which involves training doctors and medical students. We currently have:

2 Registrar's (GPST3) and 1 FY2

We also take on Medical Students and Student Nurses.

We are open to all patients living within our practice boundary in Darwen and the surrounding areas. We work in partnership with our patient's and our Patient Reference Group, to provide medical care for our patients.

We are a General Medical Services (GMS) Practice offering Primary care services for the diagnosis and prevention of disease. We help patients to manage their health and prevent illness. Our GPs assess, diagnose, treat and manage illness. They carry out screening for some diseases and promote general health and wellbeing.

Our GPs act as a patient's advocate, supporting and representing a patient's best interests to ensure they receive the best and most appropriate health and/or social care. Our GPs also provide the link to further health services and work closely with other healthcare colleagues.

They may also arrange hospital admissions and referrals to other services and specialists, they link with secondary and community services about patient care, taking advice and sharing information where needed. They also collect and record important information from other healthcare professionals involved in the treatment of our patients.

Our GPs are also involved in the education and training of doctors, practice staff and other healthcare professionals.
